## **Overseas Study Program Participant's Pledge**

I hereby undertake to comply strictly with the matters listed below in the course of my participation in a overseas study program operated by the Asian Studies Unit , Kyoto University (hereinafter, "the University").

1. I am applying for this program based on full comprehension of the costs involved in studying overseas and with the advance permission of my financial sponsor.
2. My participation in this program has been approved by my guarantor (relative, etc.).
3. I am in sufficient good health to engage in overseas study. (Any pre-existing conditions or current medical treatments must be reported.)
4. I am personally responsible for dealing with any accidents, illnesses, etc. occurring between my departure from Japan and my return to Japan after the program. I will also notify the University staff in charge of any such occurrences.
5. I am personally responsible for any liability for damage to property or person caused by my own negligence between my departure from Japan and my return to Japan after the program.
6. I will take out overseas travel insurance (unlimited medical care and rescue expenses) for this overseas study, covering the period from my departure from Japan until my return to Japan.
7. I understand that the University may decide to cancel or postpone my overseas study program or order me to return to Japan, in light of public safety and other conditions in the country and/or region in which my host university is located. In such cases I will comply with the University's directions promptly, and will not hold the University responsible for any loss or damage incurred as a result thereof, including cancellation fees and other applicable charges.
8. I fully comprehend the purposes of this overseas study program and will devote myself to my studies at the host university. I will in principle attend all prescribed classes in the program. (If non-attendance, late arrival or early departure is necessary in some unavoidable circumstance, I will be sure to notify the class instructor in advance.)
9. While overseas I will comply with the laws of my destination country and the regulations of my host university, and behave as a responsible student of the University.
10. However, I also undertake to comply with the laws of Japan regarding consumption of alcohol. (Alcohol should not be consumed if under 20 years of age, regardless of the laws of the destination country.)
11. I will not drive a motor vehicle under any circumstances (bicycles are acceptable). I will comply with all local traffic laws.
12. I will complete all procedures required as part of this program by the due date without fail. These procedures include the payment of a cancellation fee if withdrawing from the

program.

13. After completing the program, I will actively respond to requests from the Asian Studies Unit for assistance in promotional activities.
