## **Contemporary Media Technologies and Nationalism: Asia and the World**

The purposes of the International Workshop for Social and Information Studies (SIS) in Gunma University are 1) to provide early career scholars who do not have fulltime teaching positions an opportunity to give presentations in English and 2) to exchange opinions with peers and middle-career researchers from various parts of the world to make stable yet flexible academic linkages.

This year, The Organizing Committee of the International Workshop for SIS aims to focus on the uses of contemporary media technologies and nationalism.

In recent years, we have begun to observe a lot of nationalistic movements on our societies such as 'XXX-First', whose followers appeal to a wide group of people to place the benefit of their belonging country above anything else. Of course we immediately note that these appeals often have inclination to limit the scope of being a national citizen to smaller ethnic group.

There seems to be a correlation between the progress of those phenomena and contemporary media technologies. For example, "Cyber Cascade" (Sunstein 2007), a type of Group Polarization, is supported by the personal computer and the portable devices being accessible to the Internet which makes many and unspecified people connect to each other. Additionally, these phenomena have had the tendency to be accelerated by the information which is not necessarily based on the fact such as 'Fake News'. On the other hand, those contemporary media technologies are absolutely imperative for the people including foreign migrants and their supporters, who are often regarded as 'unpatriotic' by the followers of contemporary nationalism, to survive and associate with each other.

The above confirmation is a popular generalization and we can easily imagine that the relationship between contemporary media technologies and nationalistic movements differ from one country (area) to another country (area). One of the purposes of this workshop is to share the actual conditions and the agendas of that relationship through various methods of academic research.

On the other hand, in Benedict Anderson's remarkable book *Imagined Communities: Reflections on the Origin and Spread of Nationalism* (Anderson 2016), print capitalism is drawn attention as one of the origin of nationalism. What we have to notice here is that he deduces his analytical perspective and findings from his case studies in Southeast Asian countries. If we can find a lot of nationalistic movements supported by contemporary media technologies all over the world, our facing situation may

be able to be described as ‘many spectres of comparisons’ in accordance with Anderson’s expression being derived from José Rizal (Anderson 1998). Another purpose of this workshop is, as is shown in the subtitle of our workshop, to figure out the perspective for the analyzation of nationalism supported by contemporary media situations by having an in-depth discussion with presenters, keynote speakers and discussants from Asia and the world.

We are looking forward to hearing from a lot of applicants who are trying to examine this challenging theme.

### 1. Schedule for the International Workshop for Social and Information Studies (SIS):

Jun. or Jul. 2018 Publication of the Special Issue of the Journal of Social and Information Studies (tentative, from the Faculty of Social and Information Studies, Gunma University)

### 2. Number of Presentations: Maximum 4 presentations

### 4. Venue: Aramaki Campus, Gunma University (Maebashi city, Gunma, Japan)

5. Travel and Accommodation Grants: **Only presenters** are eligible (**1 person per presentation**) (for details, please see note 6). These will be funded by Gunma University.

## **II. Notes for the International Workshop for Social and Information Studies in Gunma University**

1. Topics: Related to contemporary media technologies and nationalism

2. Number of presentations to be accepted: Maximum 4 presentations

3. Deadline for Application: **Sep. 20, 2017 (JST)**

4. Eligibility for applicants: Ph. D. students, Ph. D. candidates, post-doctoral fellows, and similar positions. Master course students are also welcomed. However, those who have fulltime teaching positions are not eligible.

6. Travel and Accommodation Grants: The Organizing Committee will arrange hotel accommodation for **presenters from overseas (1 presenter per presentation)** from the 23<sup>rd</sup> to 25<sup>th</sup> of November maximum (check-out on the 26<sup>th</sup>). A round-trip air ticket (from the nearest airport of the university/institution to which the presenter belongs to Narita/Haneda International Airport) and a round-trip train/airport bus ticket (from Narita/Haneda International Airport to Gunma University), for the most direct and economical route to Gunma University for **1 presenter per presentation**, will also be covered by the Organizing Committee.

If you extend your stay in Gunma or Japan, you should arrange additional accommodation individually at your own cost. The Organizing Committee **CANNOT** provide any fees regarding the obtainment of a visa and/or travel insurance. You will need to cover daily expenses such as food and local transport with your own funds.
