### About the Title

アジアの社会では「家族」にしばしば特別な文化的・社会的価値が付与され、現在進行中のその変 化に深い社会的関心が向けられています。しかし、目をこらして見ると、アジアの家族と親密な関 係、およびその変化の道筋には、大きな多様性と、ある種の共通性があることがわかります。

収録論文は、歴史と現代、理念と現実、異なる社会階層間の家族実践の違いなど、親密性の諸相に さまざまな角度から光を当てています。また、親密な関係のみでなく、私的領域と公的領域の相互 作用を扱う章も多く含むのが特徴です。「中国化」「インド化」「イスラム化」「近代化」「グロ 一バル化」という多様な文明化の交錯についても論じています。

「家族イデオロギー」「家父長制」「セクシュアリティ」「結婚」「ケアレジーム」「ジェンダー」 の全 6 部で構成されており、担当編者によって書き下ろされた各部のイントロダクションでは、収 録論文で扱われるテーマを、より広い知的・社会的コンテクストに位置づけて再論しています。

社会学、家族研究、ジェンダー、歴史学、社会政策、教育社会学、政治学、法学、人類学、人口学 など、社会科学および人文学のさまざまな領域において、「家族」「親密性」「アジア」に関心を 持つ研究者・研究機関必備のレファレンスとしておすすめします。
